

Primary NCS Intro:

Good evening and welcome to the Central South Carolina CARC Simplex Net.

Your Control Station this evening is _____ (*callsign phonetically*) and my name is _____.

This net meets on the 1st and 3rd Wednesdays of each month at 7:30 PM on frequency 146.400 MHz. All licensed amateurs are welcome and encouraged to participate.

The purpose of this net *is*:

- to learn and practice simplex communication
- to verify station equipment is in good working order, **and**
- to familiarize participants with whom we can make contact without using repeaters.

Note to NCS and Alternate Net Controls

Confirm and make note of 1 or 2 alternate net control operators from different locations for the net. This can be done prior to or during the net. Alternates must be available to remain through the end of the net. (**Reminder:** Lower your squelch.)

(Optional at the discretion of the NCS) – Include a topic/question, ideally one with a simple, short response.

Our topic/question this evening is:

As you check in, please respond to the topic/question.

Important - Before we start taking check-ins, we'll pause and let each of the Alternate Net Controls make a call to the net. Each alternate will make a call including the topic/question, if there is one. We'll hold check-ins for later.

(EACH) ALTERNATE NET CONTROL INTRO:

Good evening and welcome to the Central South Carolina CARC Simplex Net. This is _____ (*callsign phonetically*) and my name is _____. I'll be an Alternate Net Control Station this evening.

Remember, whatever the NCS covers needs to be communicated by each alternate NCS. If you don't happen to remember the topic (or question) it's fine to ask the NCS to repeat them.

Alternates NCS need not take check-ins by area, unless requested by the NCS.

Note: This is not necessary for any Alternate NCS unable to take additional check-ins.
